OUR FOCUS ON ALICE

In 2024 we introduced ALICE-households that are Asset Limited, Income Constrained, and Employed to better serve the working families in our communities who earn more than the poverty line but still struggle to afford essentials. These are neighbors, friends, and workers whose wages often can't keep up with costs like housing, childcare, transportation, or healthcare.



The latest report highlights that despite Minnesota's continued economic growth, more than one-third of residents are still being left behind financially. It emphasizes the need for leaders at every level of government and policymaking to recognize how widespread ALICE households are across the state and to strengthen public systems that create opportunities for families to thrive.

EDUCATING ABOUT ALICE

United Way Lakes and Prairie offers ALICE presentations and workshops designed to fit your organization's schedule and goals. Sessions can range from a 15-minute overview to a 3-hour poverty simulation workshop. Each experience helps participants understand the realities faced by ALICE households, highlights local data, and explores how community programs are working to remove barriers and create pathways to stability.

We host Poverty Simulations that are three-hour interactive workshops that puts participants in the shoes of poverty households, navigating real-life challenges like paying bills, accessing resources, and managing unexpected setbacks. Held in a large group setting, it's an engaging way to strengthen financial understanding, build empathy, and foster teamwork and culture within your organization.

ADVOCACY FOR ALICE

This summer, nearly 450 United Way leaders from across the country gathered in Washington, D.C. for United Way Worldwide's annual Advocacy Forum, Capitol Hill Day. Representing Minnesota were Jen Jabas, Executive Director of Lakes and Prairie United Way, and Stephannie L. Lewis, Associate Vice President of Advocacy and Community Impact at Greater Twin Cities United Way.

400+ UNITED WAY ADVOCATES ATTENDED



Jen brought a vital rural perspective, highlighting the challenges ALICE families face in Rural Minnesota, from limited access to affordable childcare and transportation to gaps in digital infrastructure and housing.

Conversations with members of Congress focused on strengthening the 211 helpline and advancing the ALICE framework to ensure national policies reflect the realities of working families.



ALICE ACROSS OUR REGION

ALICE data varies across communities, and one of the strengths of this research is that it can be broken down by county. This gives us a clearer picture of how financial hardship impacts each part of our region.

Some groups face financial hardship at disproportionate rates, with 60% of the youngest and 49% of the oldest households in Minnesota falling below the ALICE Threshold, compared with 27% of households headed by someone age 25-44.


Housing continues to be a major challenge for struggling families, with an average of 71% of renters and 56% of homeowners below the ALICE Threshold spending over 30% of their income on housing.







YOUTH OPPORTUNITY

CREW - Community, Resources, Engagement, and Wrap-around Services

CREW is facilitated by a United Way team member who walks alongside families, helping them navigate nonacademic challenges and connecting families with essential resources, from food and housing to transportation.

DOLLY PARTON IMAGINATION LIBRARY

The Dolly Parton Imagination Library is a free book gifting program that mails high-quality, age appropriate books each month to children from birth to age five. Serving Otter Tail and Wadena Counties.

STUFF THE BUS

Every year, the United Way team organizes the registration and distribution of new backpacks stuffed full of necessary school supplies for students to start their school year with confidence. Backpacks are made available for pick up to registered families before the start of the school year.

TRAVELING TREE HOUSE

The Traveling Tree House is a mobile learning center staffed by United Way team members who are licensed educators that provides free literacy based programming over the summer months.

COMMUNITY IMPACT COALITION (CIC)

The coalition works to create lasting community impact by identifying and addressing local needs while serving as a resource to one another. United Way coordinates these meetings in Douglas and Pope Counties.

211

United Way's 211 service is a free, confidential resource that connects people to local help for housing, food, mental health, and other essential needs. Available 24 hours a day, seven days a week, 211 provides real-time support and referrals to trusted community programs, helping individuals and families find the assistance they need when they need it most.

DAY OF CARING

The Day of Caring is a United Way program coordinated in partnership with participating schools held each May, giving students the opportunity to volunteer in the community and complete projects that make a meaningful local impact.

POVERTY SIMULATION

A Poverty Simulation is an interactive experience where participants take on different roles that place them into typical scenarios that **ALICE** families face. The goal of those participating is to help participants understand what it is like to meet the needs of their family for one month on a low income.

Our CIC Coalition brings together more than 50 nonprofits to share resources, identify local needs, and pursue collaborative solutions.
